
EXECUTIVE SUMMARY


Highlights of Accomplishment

A total of 405 projects was enrolled in the RPMES Monitoring Plan by 25 implementing agencies - 16 RLAs, 3 SCUs, 3 PLGUs, 2 GOCCs and 1 hospital.


Eighty nine projects were already completed as the 3rd quarter ended. This is 22 percent of the total 405 projects targeted for completion in 2018. Thirty four or around eight percent are yet to be implemented in the last quarter of the year. The remaining 282 or around 70 percent of the total projects were in various phases of completion. Of the 282 on-going projects, 88 or 31 percent were behind schedule, 49 or 17 percent were ahead of schedule and 145 or 52 percent were on time.





In terms of physical accomplishment by sector, only the Social Development and Environment Sectors posted positive slippages. The Infrastructure sector exhibited the highest negative slippage at 9.72 percent, followed by the Governance Sector with 3.46 percent and Economic Sector with 0.85 percent.

Overall, physical performance was 75.67 percent, short by 0.63 percent of the 76.3 percent target for the quarter.



With regard to financial accomplishment, out of P8.559 billion allotted for the year, total releases reached a little less than six billion pesos (P5.972 B), indicating a funding support of 69.78 percent. Expenditures amounted to P5.908 billion, representing almost 99 percent fund utilization. By sector, the Economic Sector, with P1.05 billion programmed amount for the quarter, had the highest funding support of 95.1 percent and the highest fund utilization rate of 99.58 percent. The Governance Sector had the lowest funding support of 52.71 percent of its total programmed amount of P1.23 million. With the meager released amount of P0.65 million for the sector, expenditure rate was 100 percent.


There were 148,748 persons employed from the projects during the period. Again, the Infrastructure Sector contributed the biggest share with almost 94 percent.

Economic Development Sector

One hundred forty-two projects responsive to the economic development concerns of the Regional Development Plan, 2017-2022 were monitored under the sector.

In terms of physical accomplishment, the sector incurred less than one percent (0.85%) negative slippage against the quarter's target of 95.33 percent. This was largely attributed to the non-attainment of the Shared Service Facilities Projects and Establishment of Negosyo Centers (NC) under the Trade and Industry Sector. Some LGUs were unable to make available sites for the NCs. The Agri-Infra Subsector also failed to reach its physical target by 2.99 percent due to the suspension of various Small Irrigation Projects and Small Water Impounding Projects caused by unworkable project sites during the targeted schedule as a result of ongoing farming activities or the monsoon rains. The Crops Subsector had a positive slippage of one percent while the Support Services and Livestock subsectors reached their targets.



On financial status, out of P1.049 billon programmed amount for the year, a total of P0.998 billion or 95.10 percent was released for the quarter. Disbursement was recorded at P0.994 billion, indicating almost 100 percent fund utilization. The Trade and Industry Subsector had the lowest funding support of 13.63 percent, however, fund utilization was 100

percent. The Agri-Infra Subsector reported a 100 percent funding support and fund utilization.



Environment Sector

Fifty four projects responsive of the RDP's goal on ensuring ecological integrity, clean and healthy environment were enrolled under the Environment Sector.

The sector posted an overall physical accomplishment of 93.74 percent, exceeding its target by 3.25 percent. This was largely due to the high accomplishments of the Blue and Green Subsectors. Both the Brown and Climate Change Adaptation/ Mitigation (CCA/M) Subsectors missed their targets by less than 10 percent each.



In terms of financial status, the sector had a funding support of 89.43 percent. Among the subsectors, the Green Subsector had the highest funding support of 90.41 percent and fund utilization of 93.83 percent. On the hand, the CCA/M Subsector had the highest fund utilization of 96.92 percent.



Social Development Sector

The overall accomplishment of the Social Development Sector, as the quarter ended was 78.17 percent, exceeding its target by 3.49 percent. This was achieved, despite the negative slippages recorded in the Health, Nutrition and Population Subsector of 47.26 percent and Education and Manpower subsector of 32.99 percent. The high accomplishment rate of the Social Protection Subsector of 82.88 percent, however more than made up for the low performance of the two sub-sectors.

The project with the highest negative slippage of 48.40 percent was the Feeding Activity of the DSWD. This was hampered by some procurement and other administrative issues encountered by the recipient-LGUs. On the other hand, the project with the highest positive slippage of 124.87 percent was the Integrated Livelihood and Emergency Employment Program (DILEEP) of DOLE. More beneficiaries were accommodated during the period compared to what was targeted.



In terms of financial status, out of the total allocation of P4.286 billion for the Social Services Sector, releases amounted to P2.985 billion for a funding support of almost 70 percent. The Social Protection Subsector recorded high releases of P2.835 billion or 71.89 percent funding support. On the other hand, the Health, Nutrition and Population Subsector registered a low funding support of 30.69 percent. With regard to fund utilization, almost all the amounts released for the various sub-sectors were utilized as the quarter ended. Only the Education and Manpower Development Subsector was unable to utilize its releases for the quarter.



Infrastructure & Utilities Sector

Overall, the actual physical accomplishment of the sector was 69.52 percent, about 10 percent short of its target for the period. This may be attributed to the low accomplishments of all the subsectors except for the Agri - Infra Subsector which reached its target, as the quarter ended. The Social

Infrastructure Subsector incurred a high negative slippage of almost 29 percent due to the delayed implementation of several SUC projects arising from bidding bottlenecks.



On financial status, out of the P2.974 billion allotted for the sector, the total amount released reached P1.766 billion or a funding support of 59.39 percent. Fund utilization rate was high at 98.76 percent.



Governance Sector

As the 3rd quarter ended, the Governance Sector recorded a physical accomplishment rate of 43.11 percent, missing its target by 3.46 percent. The non-implementation of peace and security development related projects of the PNP contributed to the low accomplishment level. The Project Double Barrel was transferred to the PDEA during the period. Meanwhile, the implementation of projects under the Development Subsector was on target.

In terms of financial accomplishment, a total of P1.2 million was programmed for the sector. The releases for the quarter was P648 million, accounting for 52.71 funding support. All the funds released were fully utilized as the quarter ended.

The Agno River Irrigation Extension Project (ARISEP) is an extension of the Agno River Integrated Irrigation Project. The ARISEP involves the construction of new main canal and five siphons including other related structures, project facilities, pre-construction/ detailed engineering, institutional development program and right-of-way payment/acquisition. Among others, the ARISEP aimed to improve farmers' productivity. The Project was scheduled for implementation from July 2015 to December 2018. As of October 15, 2018, the project has an overall actual physical

The Tarlac-Pangasinan-La Union Toll Expressway (TPLEX) consists of 3 main sections, stretching from Tarlac City to Rosario, La Union.
